Credit Card and Debit Card Service Fee Increases for Property Tax Payments

Effective March 12, 2017, services fees for credit and debit card Secured Property Tax payments will increase. This increase is primarily driven by the online third party payment processor for Secured Property Tax credit card and debit card payments. Specifically, the fee for credit cards will increase from \$5.95 plus 2.10% of the payment amount to 2.25% of the payment amount. The fee for debit cards will increase from \$3.95 per payment to 2.25% of the payment amount.

As an example, the former service fee and the new service fee for payments made with a credit or debit card for a \$6,000 Annual Secured Property Tax bill would be:

| Payment Type | Former Rate | Former Service Fee on \$6,000 Payment | New Rate | New Service Fee on \$6,000 Payment |
|--------------|----------------|---------------------------------------|----------|------------------------------------|
| Credit Card | \$5.95 + 2.10% | \$131.95 | 2.25% | \$135 |
| Debit Card | \$3.95 | \$3.95 | 2.25% | \$135 |

Electronic check (eCheck) payments continue to be free. To pay with an eCheck, you will need the Personal Identification Number (PIN), which is printed on any original tax bill. For a duplicate bill, email us at info@ttc.lacounty.gov. Please put "DUPLICATE TAX BILL" in the subject heading of your email and include the Assessor ID No. (AIN) in the body of the email. The PIN cannot be provided by telephone, e-mail or fax. We can only mail a copy of the original bill to the property address or mailing address we currently have on record. You do not need the PIN if you are paying with a credit or debit card.

To make a telephone payment, either by credit card or debit card, you will need the Electronic Fund Transfer (EFT) number printed on the Annual Secured Property Tax bill.

To make an online payment, go to lacountypropertytax.com, and select "Pay Online" under "Payment Options."

We accept partial payments. If you are not able to pay the full amount due, pay what you can on or before the delinquency date as this will reduce the balance of outstanding taxes owed.

We never ask taxpayers or property owners for personal information via email or over the telephone.
