This is the preferred process for most customers. Is this the desired expectation for the County?”	A payment gateway is a feature that the County of Los Angeles (County) would consider. Such a feature would need to interface with the County’s online payment vendor for payments via eCheck, credit, and debit card.
2.	N/A	N/A	N/A	N/A	“How many active CBT licenses are there? If possible, broken down by business type.”	Currently, there are no active Cannabis Business Tax (CBT) registrations. Initially, we plan up to 90 various licenses.
