The Los Angeles County Code, Chapter 4.72 Transient Occupancy Tax, Section 4.72.060 Exemptions, states "If a proper claim for exemption is made a tax shall not be imposed." The following designations are considered exempt: emergency shelter referrals by Los Angeles County, County-affiliated, or State agencies, including, but not limited to, referrals from the Los Angeles County Department of Public Social Services, the Department of Children and Family Services, the Los Angeles Homeless Services Authority, and the State Department of Corrections and Rehabilitation; any Federal or State employee on official business; any officer or employee of a foreign government; and, any Red Cross, Amtrak, US Postal Service, Federal Credit Union and Insurance Company employee serving on official business.

If you meet the above criteria and are exempt from the tax, file this Application Form and state those facts, declared under penalty of perjury, which qualify you for the exemption. An exemption shall not be granted to any transient except upon the submission of this Application Form made at the time rent is collected.
