PARTIAL PAYMENTS

We accept partial payments. However, we recommend you pay the total amount due. If you are unable to pay the total amount due, you must open a payment plan, or we will sell your property at auction on Monday, October 18, 2021.

PAY THE BALANCE IN FULL

The enclosed Statement of Prior Year Taxes shows the amount to pay, which includes taxes, penalties and costs. It also shows the date we must receive your payment. If you pay after that date, you will owe more penalties. To find the new amount due, please contact my office at 1(213) 974-2111 or Toll Free Number 1(888) 807-2111. If you choose not to open a payment plan to stop the sale of your property, we must receive payment in full in my office by <u>5:00 p.m.</u> Pacific Time, Friday, October 15, 2021.

PAYMENT OPTIONS

Pay Online: Go to **propertytax.lacounty.gov** and select "Pay Property Taxes," then choose a payment method.

Pay By Mail: Submit payment with stub from the Statement of Prior Year Taxes in the enclosed envelope.

Your right of redemption will end at <u>5:00 p.m. Pacific Time, Friday, October 15, 2021</u>, which is the last business day before we sell your property at the 2021A Public Auction on Monday, October 18, 2021. This means you will no longer have the right to pay your delinquent secured property taxes and stop the sale of your property.
