SUBJECT: **FISCAL YEAR 2020-21 CASH FLOW PROJECTION**

Attached is the latest cash flow projection for the General Fund and Hospital Funds. The estimated June 30, 2021 combined cash balances for the General Fund and Hospital Funds are positive \$551 million. This amount remains unchanged from the previous month's estimate.

Short-Term Outlook

Our previous report estimated the January 31, 2021 cash balances at positive \$1.018 billion. The actual cash balances were positive \$1.047 billion. The variance of \$29 million was largely due to higher than anticipated property tax collections. The estimated February 28, 2021 combined cash balances are positive \$449 million.

There is continued uncertainty on how the COVID-19 pandemic will impact our cash flows. We will continue to monitor the County's cash position throughout the fiscal year and provide monthly reports to your Board.
