# NOTICE OF FEDERAL SUPERFUND SITE STATUS

## UNITED STATES ENVIRONMENTAL PROTECTION AGENCY (EPA) REGION 9

The purpose of this notice is to inform the public that the property located at 718 W. Wilson, Glendale, CA 91203, Los Angeles County Parcel Number 5638-004-029 (Property), has been designated as part of the **San Fernando Valley (Area 2) Superfund Site** due to a release of hazardous substances at the site. This site has been listed on the National Priorities List under the Comprehensive Environmental Response, Compensation, and Liability Act ("CERCLA"), 42 U.S.C. § 9607.

Under CERCLA Sections 107(a) and 101(9), a person that currently owns any "facility", including a property, site or area where a hazardous substance has been deposited, stored, disposed of, placed, or otherwise come to be located, may be held liable (financially responsible) for all costs of removal or remedial action (cleanup) at the site.

In addition, EPA has placed a lien on the Property pursuant to CERCLA Section 107(I) for response costs incurred during previous removal and/or remedial action at the Property. EPA has also filed a judgment lien on the Property. EPA may in the future place on lien on the Property pursuant to CERCLA Section 107(r).

EPA encourages prospective owners of the Property to contact the regional EPA site team for more information relating to the contamination, cleanup status, and liens. EPA also encourages prospective owners of the Property to contact their own attorneys to discuss potential liability for owners or operators of Superfund sites and potential protections that may be available to certain prospective purchasers when specific steps are taken BEFORE purchasing the property.
